

Dear DAN Instructor,

RE: 2018-19 DAN AP Instructor Renewal

We at DAN AP hope it has been a successful year for you and that you have been enjoyably and actively teaching the DAN courses.

This is formal notification of your Instructor Renewal for 2018-19. The requirements for your renewal are listed below.

At DAN AP we know that sometimes it can be a bit of a financial strain to be an instructor, having to continually upgrade your skills and qualifications so, for this coming year, we will be waiving all instructor renewal fees.

You will still need to meet the requirements for renewal including membership but there will be no charge for the instructor renewal.

There are two levels of renewal, which depend on when you last taught a course and if you have been reassessed, if and as required: (1) Active; and (2) Sustaining

- All renewals apply from 1 October 2018 to 30 September 2019.

Maintaining “Active” Status

In Australia

In addition to the teaching and reassessment requirements below, all Instructors in Australia are required to:

- provide evidence of current liability insurance
- provide details of ongoing vocational competency for the courses you are licensed to teach (updates attended, certifications obtained etc.) – This must include:
 - verification that you have performed the role of a first aider/oxygen provider in a paid or voluntary capacity during the year (letter from employer or supervisor).
 - evidence of completing a VET update course, workshop, webinar or other professional development relating to assessment and training
- provide certified copies of current provider level certificates you have attained (you must have a current provider level rating for any courses you wish to teach)

Oxygen Instructor

To remain active in Australia, an **Oxygen Instructor** must have current HLTAID001 Provide CPR and current 10523NAT- Oxygen for Dive Accidents. In addition, for this current renewal, to gain Active Status **Oxygen Instructors** must have conducted at least one DAN Oxygen Provider Course and certified at least **2** new students during the year.

Oxygen Instructor-Trainers must have taught at least one DAN Oxygen Instructor Course and certified at least **2** DAN Oxygen Instructors during the year.

First Aid Instructor

To remain active in Australia, a **First Aid Instructor must** have current HLTAID001 Provide CPR (less than 12 months old) and current HLTAID003 Provide First Aid (less than 3 years old) In addition, for this current renewal, to gain Active Status you must have conducted at least one DAN First Aid Provider Course and certified at least **2** new students during the year.

In addition to re-assessment, **First Aid Instructor-Trainers** must have taught at least one DAN First Aid Instructor Course and certified at least **2** DAN First Aid Instructors during the year.

Outside Australia

Oxygen Instructor

Instructors operating in other countries in the Asian-Pacific Region, can maintain Active Status by conducting a DAN Oxygen Provider Course and certifying at least 2 new students every 2 years. However, the renewal process must be completed each year.

First Aid Instructor

To remain active, a First Aid Instructor who has not been reassessed for longer than 24 months, must be assessed on CPR. Reassessment can be arranged by attending part of a DAN Instructor Program if one is scheduled in your area, or by various other means. Please contact us to discuss the options. In addition, to remain an Active First Aid Instructor, you must conduct a DAN First Aid Course and certify at least 2 new students during the year.

IMPORTANT

A Sustaining Instructor is not permitted to teach programs until he/she has been granted Active status. Sustaining status may only be maintained for a maximum of 2 years after which it will be necessary to upgrade to Active Status. If this is not done, DAN Instructor status will expire and it will be necessary to complete another Instructor Course to regain DAN Instructor status.

INSTRUCTORS MUST BE CURRENT MEMBERS OF DAN ASIA-PACIFIC WHEN RENEWING AND WHEN TEACHING DAN PROGRAMS. Please be aware that this Instructor Renewal is additional to your personal DAN membership which must be current before we can process your Instructor Renewal.

Those instructors that belong to another DAN entity (e.g. Nationals of another DAN region) need to:

- Provide evidence of DAN Membership with this renewal application; AND
- Complete a subscription form and pay a subscription fee to DAN AP.
This is to ensure that you receive the required health and safety information and regional information.

INSTRUCTOR STATUS SOUGHT: ACTIVE SUSTAINING

- ***To maintain Active teaching status you must have taught a course AND maintained current competency during the required period – In Australia this means you must hold a current provider level rating for any courses you wish to teach and have completed a CPR course during the previous year. You must also have performed the duties of the role you are teaching (worked as a first aider) and undertaken professional development in VET Training and Assessment.***
- ***Sustaining status can only be maintained for a maximum of two (2) years.***
- ***There will be an administration fee to re-activate from Sustaining status***

DAN AP MEMBERSHIP (Membership must be current for Instructor renewal)

CURRENT DAN AP MEMBERSHIP NUMBER _____

Before they can be renewed in ACTIVE status Australian Instructors MUST provide:

- Copies of current provider level certificates
- Evidence of current liability insurance
- Evidence of current vocational competency
- Evidence of professional development in VET during the 2017-18 year. (contact DAN Training to see what constitutes professional development)

Note: As previously advised ALL Australian Instructors will also need to ensure that they hold the correct Certificate in Training and Assessment as of April 1st 2019.

This means that those who currently hold the TAE40110 certificate will need to provide evidence of completing the BOTH the following units:

- TAALLN411 – Address adult language, literacy and numeracy skills
- TAEASS502 – Design and develop assessment tools

Instructors who have completed the TAE40116 will have these units as part of their Certificate already.
